- 10. Horsesqualify on the basis of time and/or order of finish in time trials. The finish times of horses in trial races are dendyrtinede limitations of the electric timing device. The sole exception to the preceding is when two (2) or more havseislentical times in the same trial race, then order of finish shall also determine preference in qualifying for the finals.

No changes will be made in the recorded times of time trials to account for head, tail and cross winds, off track, ete. **Steptulohith** timer device malfunction during any time trial, finalist from that particular trial race will be determined flicial hand timing. Hand timing will be conducted by no less than three (3) reputable and disinterested persons.
